



'Clean-Up and Create' a Bright New Future - Terms & Conditions

Eco Sculpture Art and Posters to help clean up our World

Terms and conditions of entry

1. The competition is open to school pupils and uniformed group (scouts, girl guides, army, sea and RAF cadets) who are resident in Hampshire and Sussex, aged between 5 and 16 on the closing date of the competition - 12 noon on Monday 10th July 2020.
2. Against each competition age category there are 2 entry types: Eco sculpture art (no size limit, materials - litter or unwanted waste resources); Poster (no size limit, might include waste resources).
3. Entries can be made by individual pupils, groups or classes for the KS entries, the primary collaboration and secondary collaboration can be across age groups i.e. might be an eco council entry. More than one entry can be submitted per competition age category.
4. Any contact details supplied will be used solely for administering the competition and will not be published or provided to any third party without the explicit permission of either the Head Teacher of the entering school or the teacher within the school responsible for their participation in the competition.
5. The deadline for receiving entries is 12 noon Monday 10th July 2020. Any entries received after this deadline will not be considered.
6. Only entries that comply with all entry instructions will be accepted.
7. A representative of the entrant's school must submit the entry on the pupil's behalf and by doing so agrees and accepts: a) these terms and conditions; b) that South Downs National Park Trust may publish competition entries both in print and online, including on their websites, social media channels, and for PR purposes; c) that the winning pupil(s) may be invited to participate in publicity arising from this competition.
8. Entries will be accepted on the Clean-up and create Competition Form, download from www.southdownstrust.org.uk/clean-up.

This should include completed entry form, image(s) of eco sculpture art and any associate message and photo(s) or scan(s) of poster entry(ies).
10. Please ensure that the attachments do not exceed 10MB in total. If we need a larger file size of any image(s) or scan(s) we will contact the named person on the entry form.
11. In all cases, each photo or scan should detail the school name, town, pupil(s) name(s)/class, corresponding with the entry form.

12. South Downs National Park Trust takes no responsibility for late entries, or entries not successfully uploaded.
13. Entries must be the original work of the entrant(s) and not copied from any other source.
14. The judging panel will select one winning entry from each of the 14 competition age categories which have been received by the competition deadline, 12 noon on Monday 10th July 2020.
15. The decision of the judges is final and at the absolute discretion of South Downs National Park Trust's panel. No correspondence will be entered into.
16. The winning eco sculpture art and poster entry per age category will receive £150 for their school. Individual pupil entries which have been entered through the school, we leave it to the discretion of the school as to the allocation of the prize money. We will accept entries from individual pupils have chosen to make their art outside of school, but their entry will need to be supported by their parent or guardian.
17. The winning schools/entries will be contacted by email, telephone or by mail by 14th July. If the winning schools/entries cannot be contacted after reasonable attempts have been made, South Downs National Park Trust reserves the right to offer the prize to another competition entrant.
18. South Downs National Park Trust reserves the right to cancel this competition without notice at any stage if it is deemed necessary at the absolute discretion of SDNP or where events beyond its control prevent proper administration of the competition.
19. These terms and conditions and any disputes arising out of them shall be governed by and construed in accordance with English law.
20. The promoter of this competition is South Downs National Park Trust in partnership with Sussex Green Living. The data controller of this competition is South Downs National Park Trust.
